Dear U.S. Attorney Pirro:

In July 2022, Chairman Grassley began a congressional investigation into Arctic Frost which was the Federal Bureau of Investigation's (FBI) investigation into the Trump campaign.¹ Arctic Frost eventually became Special Counsel Jack Smith's electoral case against President Trump. Since then, we have made whistleblower records public that have exposed how partisan FBI agents and Department of Justice (DOJ) prosecutors opened, approved, and advanced the investigation against President Trump.² Whistleblower documents have also exposed that the Biden FBI expanded the scope of Arctic Frost to include at least 92 Republican groups and individuals, including Charlie Kirk's Turning Point USA.³ The records we've made public show that Arctic Frost was a politically motivated fishing expedition to investigate Republican groups and individuals.⁴

Recent revelations have further underscored the clear political motivations of Arctic Frost. On October 6, 2025, FBI Deputy Director Dan Bongino informed us that as part of Arctic Frost, in 2023, officials in the FBI's Washington Field Office obtained tolling data from the personal phones of at least nine Members of Congress—despite none of these members being a target of an investigation.⁵ This is an outrageous and obviously unconstitutional breach by the Biden DOJ.

Section IV of Volume I of Special Counsel Smith's Final Report states that as part of their investigative process "in the Election Case," the Special Counsel's Office obtained records from "the U.S. Attorney's Office for the District of Columbia, and other federal agencies, including the National Archives, Department of Homeland Security, Department of Defense, and Office of the Director of National Intelligence."⁶

Accordingly, we request that you provide us with all records that your agency provided to Special Counsel Jack Smith's Office as part of its Election Case in unredacted form no later than October 24, 2025.⁷
