13	SEC. 5. REPORT TO CONGRESS.
14	(a) In General.—Not later than 180 days after the
15	date of the enactment of this Act, and not later than De-
16	cember 31 of each of the 3 successive years, the Secretary
17	of Homeland Security and the Secretary of Defense shall
18	jointly submit a report to the appropriate congressional
19	committees that includes a description and assessment of
20	the program established under section 4.
21	(b) CONTENT.—The report required under subsection
22	(a) shall include—
23	(1) a detailed description of the program estab-
24	lished under section 4, including—
25	(A) programmatic elements;

1	(B) goals associated with those elements;
2	and
3	(C) a description of how the elements and
4	goals will assist in meeting statutorily man-
5	dated staffing levels and agency hiring bench-
6	marks;
7	(2) a detailed description of the program ele-
8	ments that have been implemented under section 4;
9	(3) a detailed summary of the actions taken
10	under section 4 to implement such program ele-
11	ments;
12	(4) the number of separating service members
13	made aware of Customs and Border Protection Offi-
14	cer vacancies;
15	(5) the Military Occupational Specialty Codes,
16	Air Force Specialty Codes, Naval Enlisted Classi-
17	fications and Officer Designators, and Coast Guard
18	Competencies identified as transferable under sec-
19	tion 3(a) and a rationale for such identifications;
20	(6) the number of Customs and Border Protec-
21	tion Officer vacancies filled with separating service
22	members;
23	(7) the number of Customs and Border Protec-
24	tion Officer vacancies filled with separating service
25	members under veterans recruitment appointment

1	authorized under the section 4214 of title 38, United
2	States Code; and
3	(8) the results of any evaluations or consider-
4	ations of additional elements included or not in-
5	cluded in the program established under section 4.
6	SEC. 6. RULES OF CONSTRUCTION.
7	Nothing in this Act may be construed—
8	(a) as superseding, altering, or amending existing
9	Federal veterans' hiring preferences or Federal hiring au-
10	thorities; or
11	(b) as authorizing the appropriation of additional
12	amounts to carry out this Act.
