Dear Mr. Stankey:

We are following up on our October 11, 2025, letter which requested information concerning the collection of personal call logs of at least nine Members of Congress by the Biden FBI as part of the Arctic Frost investigation that evolved into Special Counsel Smith's election case.¹ Since that letter, our offices have been made aware of at least 44 grand jury subpoenas, 43 to Verizon and one to AT&T, issued by former Special Counsel Smith. Of those, three subpoenas to Verizon and one to AT&T requested information associated with at least 13 Members of Congress.

According to your response, Special Counsel Smith's team sent AT&T subpoenas requesting the phone records of Senator Cruz and an unnamed Member of Congress.² On October 28, 2025, during a call between AT&T and our offices, our staff asked whether AT&T had received any subpoenas related to the Arctic Frost investigation, including prior to Jack Smith's appointment as Special Counsel, irrespective of them being connected to members.³ In response, representatives for AT&T stated that they received more than 10 but less than 20 subpoenas from Jack Smith's team, but were unaware of any subpoena requests related to Arctic Frost prior to Jack Smith's appointment.⁴ AT&T has asserted to our staff that the subpoenas they did receive are unrelated to members; however, AT&T has failed to produce them to us.⁵ It is unclear the extent to which AT&T has conducted a search of records prior to Jack Smith's appointment as Special Counsel.

Our offices have obtained an email exchange from May 19, 2022, to May 22, 2022—prior to Jack Smith's appointment—related to grand jury subpoenas in the Arctic Frost matter between FBI, the Department of Justice (DOJ), the United States Postal Inspection Service (USPIS) and the National Archives and Records Administration (NARA).⁶ The subject line states "Arctic Frost Returns/Uploads," and the email reads:⁷

Jack Smith was appointed Special Counsel on November 18, 2022.⁸ The email records appear to indicate that your company was in fact issued a subpoena related to Arctic Frost prior to Jack Smith's appointment as Special Counsel. As such, we are requesting that you provide the following information no later than November 26, 2025:

1. Is the information provided in the email exchange between FBI, DOJ, USPIS, and NARA accurate? If so, please explain and provide all records, including all records produced pursuant to the legal process referenced in the above email, relating to Members of Congress.⁹
 - a. If you find that the information is inconsistent with your records, please explain the search that you conducted to reach that conclusion.
2. What steps has your company taken to identify additional subpoenas relating to Members of Congress pursuant to the Arctic Frost matter prior to Jack Smith's appointment as Special Counsel?
3. Did the grand jury subpoena referenced in the DOJ, FBI, USPIS, and NARA email include requests for information on Members of Congress?

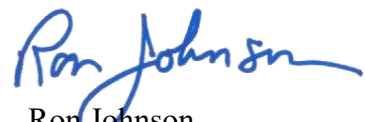
We request all records relating to Members of Congress as part of the Arctic Frost investigation, including, but not limited to, subpoenas your company received prior to Jack Smith's appointment as Special Counsel. In an effort to assist your search for subpoenas or legal process, and associated records connected to Arctic Frost, before or after Special Counsel Smith's appointment, attached to this cover letter is a list of search terms we have identified. The terms include what we believe to be an identification number associated with subpoenas issued as part of Arctic Frost; the names and known email addresses of FBI and DOJ personnel involved in these investigations; and a series of additional phone numbers. You should use the provided terms to search for any subpoenas or other legal process, as well as any related records, for the time period from January 1, 2022, to January 20, 2025.
